Any portion of your comment extending past three (3) minutes may not be read aloud due to time restrictions. If a general public comment or comment on a business item is received after 1:00 p.m., efforts will be made to read your comment into the record. However, staff cannot guarantee that written comments received after 1:00 p.m. will be read. All written comments that are not read into the record will be made part of the meeting minutes, provided that such comments are received prior to the end of the District Board meeting.

In addition, should you wish to comment during the meeting, you are welcome to comment during the public comment period. These comments will be recorded and uploaded to the District website.

- The Public Comment period of the Board meeting can be used to make additional comments during the meeting. These will be recorded and uploaded to the District website.
