Introduction

Courage is Love in Action

"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness – That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, –That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness.

Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security." ~ *Excerpt from The Declaration of Independence – IN CONGRESS, July 4, 1776 – On Which the Constitution of Our Great Nation Was Founded.*

We Are a Constitutional Republic, Not a Democracy

Contrary to what most U.S. citizens understand, we are a Constitutional Republic, *not* a democracy. Our Constitution provides for the protection of our God-given, unalienable rights and also provides for the protection of those in the minority against the will of the majority. The framers of our Constitution understood, through centuries of persecution under tyranny, that the will of the majority, if imposed, will always lead to the violation of human rights, God-given rights and civil liberties.

Above all, our Constitution recognizes that our rights come from God, *and not from Government*; and that the purpose of Government, first and foremost, is to protect our God-given rights.

Legal Decisions and Briefs That We Should Remember

"A law repugnant to the Constitution is void. An act of Congress repugnant to the Constitution cannot become a law. The Constitution supersedes all

other laws and the individual's rights shall be liberally enforced in favor of him, the clearly intended and expressly designated beneficiary."

~ Marbury v. Madison, 5 U.S. 137 (1803)

"An unconstitutional act is not law. It confers no rights; it imposes no duties; affords no protection; it creates no office. It is, in legal contemplation, as inoperative as though it had never been passed."

~ Norton v. Shelby County, 118 U.S. 425 (1886)

"The general misconception is that any statute passed by legislators bearing the appearance of law constitutes the law of the land. The U.S. Constitution is the supreme law of the land, and any statute, to be valid, must be in agreement. It is impossible for both the Constitution and a law violating it to be valid; one must prevail. This is succinctly stated as follows:

The general rule is that an unconstitutional statute, though having the form and name of law, is in reality no law, but is wholly void, and ineffective for any purpose; since unconstitutionality dates from the time of its enactment, and not merely from the date of the decision so branding it. An unconstitutional law, in legal contemplation, is as inoperative as if it had never been passed. Such a statute leaves the question that it purports to settle just as it would be had the statute not been enacted.

"Since an unconstitutional law is void, the general principals follow that it imposes no duties, confers no rights, creates no office, bestows no power or authority on anyone, affords no protection, and justifies no acts performed under it...A void act cannot be legally consistent with a valid one. An unconstitutional law cannot operate to supersede any existing valid law. Indeed, insofar as a statute runs counter to the fundamental law of the land, it superseded thereby. No one is bound to obey an unconstitutional law and no courts are bound to enforce it." – 16 American Jurisprudence 2d, Sec. 177

Conflict is always an invitation to useful change. Therefore, this is a great and glorious time, a perfect time to enact this change, *community-by-community, state-by-state.*

In this regard, to secure the above in alignment with our Constitution and the conscience of the individual, we will need the citizenry to become fully engaged in their governance, *something that we do not now have.*

Human Contact and Solidarity

By convincing the healthy that they are sick when they don't have any symptoms, and then by discriminating against them (vaccine passports) to create a second-class citizenry - and by grossly inflating SARS-COV2 infection and death counts based on computer model projections, even when accurate, real-time numbers are available - and by using a virus that is no more dangerous than that occurring in an extended flu season (99% recovery rate among those with healthy immune systems) - thereby breaking the economy that the middle class relies on - and by establishing a state of emergency with no clear designated end, **our current government is attempting to obliterate solidarity by making us frightened of each other!** What better way to punish dissent under the guise of protecting us!

Fascism

Under a fascist society, there is no need for enforcing the mandates of tyranny. Through engineered consent, and by shifting the culture of societies to a culture based on the corruption of greed that provides those commanding huge amounts of financial wealth the ability to bribe people for total socio-economic control, the masses will police each other. Fascism is a fear-based culture, by design.

Why Do We Need Liberty Action Councils?

To Develop Direct and Sustained Contact With Legislators and Other Elected Officials!

Currently, the checks and balances provided by our Constitutional Republic under the Constitution that is the highest law of governance in America have been practically destroyed *due to the negligence of the public* in allowing government to remove them. Some of this statement also applies to the current state of affairs under Covid and our Ohio State Constitution.

This is not a matter of a 'system' being broke. Systems are made up of the people who design and run them. So, terms like 'it's the system' are used to distract us from demanding transparency and accountability on the part those individuals who are complicit in placing profits and personal gain above the people. ***Will we be ruled or will we insist on actual governance for the people, that is by the people?*** Because there is a difference in these two. And any system established by people that is not working in the best interest of the people, can be changed by people – us!

The Overrated Reliance On the Executive Branch

"Governor, to see that laws are executed; may require written information. §6 He may require information, in writing, from the officers in the executive department, upon any subject relating to the duties of their respective offices; and shall see that the laws are faithfully executed."

As just one example, under Covid emergency mandates in Ohio State, the powers vested in the state legislature have been abdicated to the Executive Branch of the Governor and state and local health departments, in violation of our state's constitution (see Article II, Section 1, paragraph D).

During the declared state of emergency, we have heard testimony in the statehouse on the part of elected officials that, under Covid, "there should only be one general making decisions." This is precisely what our state Constitution is designed to prevent!

There are only five pages dedicated to delineating the powers of the Executive Branch in Ohio. In delineating the powers of the three branches, *the predominant number of pages in our state's Constitution are dedicated to the powers of the legislature*. That's because only the legislative body has the power to make law and declare rulings and mandates under such law.

Most of the Ohio citizenry are not even aware of this, as evidenced by the number of citizens, local elected officials, law enforcement and business owners who, under Covid, have wrongly stated that the Governor's mandates are law!

The power of the Executive in Ohio is very limited, as is the case with our Federal Constitution. **Therefore, it is of the utmost urgency to ensure that any laws on the books, for example, the Ohio Revised Code, be revised or repealed by the state legislature to bring the code into alignment with the Ohio State Constitution.**

In addition, every elected official in the state of Ohio takes an oath upon taking office, to uphold our Constitution. **This means they have sworn to protect our God-given Constitutional rights. And they have to be held to their oath *by us*.**

Now look at the above and ask yourself if current affairs in our state are in alignment with the separation of powers and checks and balances under our Constitution.

The public gives too much power to the Executive branch on both the state and federal levels, a branch that has the least delegated powers under the Constitution. This has paved the way for Presidents, Governors and departments of the Executive Branch to successfully supersede the separation of powers designed to protect our Constitutional rights and to prevent big government from running amok.

They have done so by pandering to corporate special interest in which they take bribes in return for mandating legislation and issuing executive orders that actually protect corporate economic interests and provide for our tax dollars to be spent to support corporate and private economic interests.

For example: *Although well meaning*, most officials in this branch are not educated on the science of viruses/virology and toxicology and alternative, inexpensive, non-toxic therapies for treatment. Instead, they rely heavily on government bureaucrats to provide them with data from computer projection models, rather than data from professionals on the ground who

are successfully treating patients and clients. These bureaucrats have kept their positions for decades by serving the special interest of big business and, in this example, Big Pharma.

In this way, corporate special interest and that of the wealthy elite often hold the executive branch hostage (and, at times the legislature also). We the people no longer have the greatest voice in our government. And the wealthy elite in both political parties often work together *for personal gain and advancement of their ideologies*. So, this is not about democrats, republicans or independents. It's about protecting our God-given rights under the Constitution.

The Legislative Branch

"§1 The legislative power of the state shall be vested in a General Assembly consisting of a Senate and House of Representatives **but the people reserve to themselves the power to propose to the General Assembly laws and amendments to the constitution, and to adopt or reject the same at the polls on a referendum vote as hereinafter provided.** They also reserve the power to adopt or reject any law, section of any law or any item in any law appropriating money passed by the General Assembly, except as herein after provided; *and independent of the General Assembly to propose amendments to the constitution and to adopt or reject the same at the polls.* The limitations expressed in the constitution, on the power of the General Assembly to enact laws, shall be deemed limitations on the power of the people to enact laws. (1851, am. 1912, 1918, 1953)"

The longest section delineating the three branches of our state government is this section - And for a reason: The legislative branch holds the most power of governance of the three.

The Judicial Branch

"§1 The judicial power of the state is vested in a supreme court, courts of appeals, courts of common pleas and divisions thereof, and such other courts inferior to the Supreme Court as may from time to time be established by law. (1851, am. 1883, 1912, 1968, 1973)"

We the people must ensure that the current practice in the way the judicial branch functions never outweighs the powers afforded to it under the Constitution.

Special Interest Lobby

The challenge we have in our communities is fighting the corruption of greed that has infected our government.

Ours is a capitalist society. Big business operates with the understanding that corporations provide economies on which communities and states thrive through the development and sale of their products and services, in which people are also provided jobs.

Of course, the hubris of upper management and owners of these conglomerates is such that they forget that it is their often-underpaid employees who make their companies successful. In addition, corporate greed has fueled the notion that government is in debt to private industry for creating economies.

It's not enough and it is never enough that these conglomerates make, as their reward, vast sums of money. They believe they are the saviors of the people, rather than the servants of the people and, in this regard, they feel they have the right to own government. *Again, this, of course, is due to the corruption of greed and our own complacency in reining it in.*

The following is an example that should be heeded. Although it references the U.S. Congress, we have similar issues here in the state of Ohio.

Lobbyists

1. For every member of the U.S. Congress, there are 4 special interest lobbyists representing corporations.
2. These lobbyists call on our government representatives on a constant basis.
3. Corporations are still the primary source of the introduction of bills into the U.S. Congress.
4. In order to get these special interest bills passed, conglomerates finance election and re-election campaigns, offer valuable perks to

legislators and donate and/or offer grants to fund causes connected to legislators.

5. We, the people, introduce few bills to the legislature. In fact, it's unheard of that bills to be considered are presented for consideration of sponsorship by communities of citizens, even though that is our right.
6. In a growing number of cases (not all), conflicts of interest often prevent legislators from initiating bills on behalf of their constituents, even when their constituents press for the bills to be enacted. This is largely due to the rise of the career politician (who places keeping his/her seat as a higher priority to serving the people) and the decline of the statesperson.
7. Our government does not hear from us. Because this is the case, our legislators assume that we are in agreement with whatever they say and do.

The above list is just a sampling of what needs to be addressed, and this is why we now need to plan and execute **Liberty Action Councils** in as many counties as possible in our state.

THE PLAN

Vision: A proposed minimum of 10 citizens per Liberty Action Council (can start with less – perhaps 5), **with one Liberty Action Council per county.**

I. Education and Outreach – the Citizenry

"If you don't know what your rights are, how do you know they are not already gone? You cannot exercise a right you do not know you have. If you are not exercising your rights, they are already gone."

The citizenry is ignorant of the Constitution on which our Republic is founded. Most have not read it, *nor have they read their state constitution and bill of rights that is based on the U.S. Constitution.* Therefore, they have no idea of the highest of societal laws that govern them. So, how can they even begin to protect such rights?

Therefore, a principle duty of Liberty Action Council Ohio is to begin classes, webinars, gatherings and other groups to teach people the Constitution and its efficacy for securing our rights and freedoms.

This simple training can be led by constitutional attorneys, community leaders educated in the constitution and constitutional sheriffs of the CSPOA (Constitutional Sheriffs and Peace Officers Association) or similar organizations. These trainings can also include group viewings of constitutional lessons readily available through platforms like Liberty University.

II. Education and Outreach – Elected Officials

Elected officials (who often need training in becoming public servants), many of who are elected legislators, are, in some cases, also ignorant of the Constitution on which our Republic is founded. Many of them have not read it, nor have they read their state constitution and bill of rights that is based on the U.S. Constitution. Therefore, they also have no idea of the highest of societal laws on which we are to be governed. In fact, we have met several state legislators who have told us that the Constitution is no longer relevant.

Given this fact, a principle duty of a Liberty Action Council is to also begin educating state legislators and local law enforcement in the Constitution on which they have taken a sworn oath to uphold.

This can be accomplished over breakfast and lunch sit-downs or Zoom meetings with these officials, in which they are graciously weaned on to direct knowledge of our highest, societal law.

This simple training can also be led by constitutional attorneys, community leaders educated in the constitution and constitutional sheriffs of the CSPOA (Constitutional Sheriffs and Peace Officers Association) or similar organizations.

In addition, it will be a priority of Liberty Action Councils to get legislators to enact laws that require that government officials and law enforcement officers take a written, graded test on their knowledge of the Constitution, because no elected or appointed official can be expected to uphold and protect laws and rights for which they have no detailed

knowledge (and on which they took an oath of service). And officials who fail such a test should be required to take it over and over again, until their grade is satisfactory – and the results of such tests should become a matter of public record.

III. Holistic Health and Health Freedom Education and Outreach – the Citizenry

Unfortunately, today too many people take better care of their cars and cell phones than they do their bodies.

The majority of U.S. citizens are still unaware of the many effective, *alternatives* to toxic medical interventions like most of the current vaccines, and the many pharmaceutical medications that have become commonplace. Reaching for these toxic interventions should be the last resort when all other viable, alternative therapies have been exhausted. Instead, many people in America and across the globe are stuck in the mentality of a magic pill for everything that ails them.

We understand the importance of medical interventions when absolutely necessary and are not against such interventions. However, rather than applying *effective methods for getting to the root cause of the health condition or disease*, too many people are happy to simply focus on treating symptoms. In fact, in America, we have a *sick care system*, not a health care system. Ours is a system dominated by a medical field that has been focused on symptom relief only, rather than getting to the root cause for permanent healing of the condition. This is so because there are no massive profits in cures, only in continued disease for which the symptoms alone are treated.

This has increased reliance on toxic medical interventions that have made us a society of drug users and drug dealers. *A society that promotes prevention as the first line of defense against illness is a society that will not become reliant on pharmaceutical medications.* This, then, will destroy the economies built around our sick care system that have been placed as the highest priority in maintaining, *ahead* of prevention and cure.

Therefore, one of the duties of Liberty Action Councils is to offer, share, promote and support programs that educate people in how to care for their health, *holistically, and as a matter of prevention*, by way of lifestyle

changes that are known to effectively address getting to the root cause of illness and lack of well-being.

There are growing numbers of doctors, scientific researchers and holistic health, healing and well-being practitioners with very strong track records of successfully helping people to reverse and heal chronic health conditions and diseases through lifestyle changes. This approach includes holistic, cellular nutrition through eating real, highly nutritious food, restful sleep, proper exercise, intermittent water fasting, meditation and yoga, herbal therapies and other methods that amount to healing and prevention of disease.

It is the duty of a Liberty Action Council to foster education in these alternatives so that the citizenry is fully informed about all of the very *viable choices* they have for true health care, based on prevention and getting to the root cause of the ailment.

Health Freedom

The above goes hand in hand with the necessity to educate the public in what health/medical fully informed consent is, along with the fact that *it includes the right to refuse without discrimination or other reprisal*. This form of education must include getting people to understand that *trust has to be earned* – whether that be trust in a doctor, medical professional, health/healing practitioner, or other therapist or researcher.

When it comes to health care, too often, people give their trust blindly without insisting on a complete understanding of the science (or lack thereof) on which the recommended approach/therapy is based. *Doctors and health/healing/well-being professionals are your paid consultants. They work for you and are fully accountable to you, and not the other way around.*

For example, patients/clients have to be educated in how to vet the underlying science of any diagnosis and prognosis, before accepting and trusting it, just because the doctor says so.

In this regard, fully-informed consent and the right to refuse can only be supported when people have all the facts and have considered all sides of

the 'debate' or 'argument' before exercising their right to accept or refuse any proposed health/medical intervention of any kind.

It's not their body, *it's your body* and, in the end, you are the one responsible for keeping it well, not your doctor or other health/well-being professional.

IV. Holistic Health and Health Freedom Education and Outreach – Elected Officials

As stated above for the citizenry, too many elected officials are also ignorant of the many, effective and non-toxic holistic therapies for treating chronic health conditions and diseases. Many of them only know what Big Pharma tells them. This can be easily understood by observing how our government has stood by and allowed chemical companies to poison our food and water supply with GMOs and other genetically engineered poisons.

In this regard, many elected officials overlook or are not aware of the science that supports the alternative approaches to health, healing and prevention. Even now, some are calling for all such therapies to be outlawed, and some of that is due to pressure from Big Pharma to eliminate what they feel is the competition. *Big Pharma can only thrive if people remain sick or are convinced that they are sick when they are not.*

Therefore, another primary duty of Liberty Action Councils will be to begin an extended education campaign targeted to elected officials, designed to give them a direct experience of how these holistic lifestyle approaches can improve their health and well-being permanently.

V. Education In How to Raise Candidates for Public Office

In America, in most cases, we vote for the candidates that are presented to us. Our 2-party structure provides us with few alternatives for candidates and has created a polarizing environment that makes it almost impossible for bipartisan cooperation in protecting/upholding the Constitution and serving the common good, by first protecting our God-given rights.

Most citizens have never met their candidate in person or had a face-to-face discussion with the candidate about serving and protecting their liberty. Instead, too many people vote based on viewing video clips of

campaign stops, campaign ads in popular media (media sound bites), flawed, televised debates in which the debate questions submitted are controlled by the presiding media outlet running the debate, and/or peer pressure/discussions with family members and loved ones who have also had little or no contact with candidates.

This has fostered an environment where elections have become nothing more than *public auctions*. *We, the citizenry, have allowed this to happen because, too often, we are not engaged in raising candidates who actually represent us.*

Therefore, Liberty Action Council must be actively engaged in choosing and grooming people for office who will actually represent us and serve our needs, while protecting our constitutional rights and civil liberties.

So, community-by-community, we need to foster relationships based on human contact that can be nurtured in the context of raising states people for public office. It is foolish for us to simply wait to be told who the candidates are.

In this regard, there are advocacy training portals already in place that liberty action councils can utilize to become educated in how to raise candidates. Once the council has done so, it can go about presenting candidates to the public who have been raised from inside the community, and begin to raise campaign financing.

Part of this approach will include populating legislatures with citizens who *are not* interested in becoming career politicians but, rather, want to serve for a finite period of time in which to foster creative innovations to practical, representative government for and by the people.

CAMPAIGN FINANCE

The citizenry is victim to a system run by people who will only allow those with monetary wealth to run for office. The outrageous costs connected to running campaigns, that includes hefty media buys, is executed to keep those not part of the wealthy 1% of the population from running for office.

The premise on which this is founded is that the monetarily wealthy are smarter and more fit to run government than the rest of unintelligent

rabble. However, financial wealth does not automatically equate to intelligence, particularly when many wealthy people have gotten materially wealthy by way of the corruption of greed and the unethical and criminal acts that greed renders.

This keeps good, morally and spiritually ethical people out of the election process; And this must change. For the financially rich have robbed our Republic and made our government subsidiaries of their businesses!

The Need for A Citizen's Superpac

The way to change this is for citizens across this land to band together to form Superpacs that are not associated with any political party, to raise money to run candidates for office who want to uphold the Constitution and protect our God-given, inalienable rights – candidates who will place this above party and above individual ideology.

This can be done by communities of citizens coming together with financial and campaign experts, to begin forming Superpacs to run candidates who will endeavor to change the system and enliven plans for reshaping elections around town hall meetings that are not reliant upon media ad buys and media-controlled debates.

VI. The Reading and Vetting of Bills Being Introduced to the Legislature

One of the primary duties of a Liberty Action Council will be to assemble groups of citizens in the community to read and vet every single bill being proposed to the state and federal legislatures, before those bills get out of committee and are presented for a vote.

Legislators are, at times, in the habit of reading 2-page summaries of bills, rather than reading the entire bill. Therefore, they are voting on bills that they have not fully read.

So, we, the citizenry, better know and thoroughly understand what's in these bills, before they are voted on, so that communities can make their support or lack of it known to their public servants. Bills must be considered based on the will of the people, not the special interest and conflict of interest of a select few.

Once the liberty action council understands what's in these bills, the council can act accordingly in apprising the citizenry and arranging meetings with legislators to discuss support or opposition to the bill and what actions should be taken to represent the people.

VII. The Writing and Introduction of Bills by the Citizenry for Consideration and Sponsorship

If corporations, either directly or indirectly, are allowed to introduce the majority of bills to the legislature, why can't the citizenry do the same!? *Of course we can.* In fact, if we are going to complain about bills that are being passed into law, *it is our duty to provide an alternative.*

One of the best ways to engage a citizenry is to get the citizenry educated in the bill writing process, along with how to effectively have them introduced to the legislature – just like corporate and private special interest do now.

Therefore, it will be a duty of Liberty Action Councils to engage local citizens in the education and engagement for introducing bills written by the people, for the people.

VIII. Foster Monthly Meetings Between the Citizenry and Elected Officials

If we feel that we don't have transparency and accountability in government, it's because we don't demand it. Simply complaining about a problem is not useful. *Engaging the problem is more useful.*

Right now, our government is like a big ghost operating in the shadows. Who are they? What do they do with their time when they are 'on the clock.'? Who runs what and when? The citizenry doesn't know. And yet, our tax dollars pay their salaries and they are said to represent us.

In business, there are management levels designed to monitor what is required of the employees, along with the quality of their work. With respect to governance, that management level belongs to the citizenry.

Our elected officials don't hear from us. So, they naturally assume that we agree with what they do and say. Communities don't have a strong voice in

their government because they don't insist on direct, human contact with their elected officials.

It will be the duty of Liberty Action Councils to arrange monthly meetings (and more frequently as needed) with elected officials, either in-district or at the statehouse. Such meetings must be engaged with regularity to foster relationships with elected officials based on direct contact, so that communities are heard and the message is sent, "You will be seeing and hearing from us all the time." Only then will we even begin to have governance that is for the people, *by the people*.

IX. The Monitoring of Our Schools and Community Home Schooling

For all you parents out there, when was the last time you sat in on any of your children's classes to observe for yourself what your sons/daughters are actually being taught in school? The fact is, most parents don't know, *first-hand*, what their children are being taught in school. They only know what the child decides to tell them, or what the teacher tells them.

In fact, the parent has the responsibility for teaching the child whatever is necessary for the child to meet the challenges of life, including helping the child to develop critical, independent thinking. Schools are actually supposed to be adjuncts that exist to serve the parent's intention for the child's education, until the child is mature enough to make decisions about further education for his/herself.

This is not the case in much of our school system today.

Therefore, it will be the duty of Liberty Action Councils to establish forums that represent the will of the community in how the school system must operate. This will include populating school boards with citizens who *are not* interested in becoming career politicians but, rather, want to serve for a finite period of time in which to foster creative innovations to schooling.

In addition, it will be a duty of Liberty Action Councils to foster alternative schooling by also developing a selection of citizen teachers who are themselves parents, to establish a cooperative community home schooling network.

This can be done to offer parents a choice in the education of their children through developing relationships with other parents who are teachers, while relieving them of the burden of having to home school alone, when faced with the challenges of reporting to work for a living.

Home schooling can present less of a challenge when, instead of parents or a single parent having to face the burden of schooling children on their own while also working a job or running a business, several competent teachers in the community can take up the charge of educating that community's children. In this way, home schooling Co-ops can be established within communities. In fact, this is the way in which schools like the Rudolf Steiner School first got started. Workers at the Waldorf-Astoria cigarette factory needed help in home schooling their children due to their workload, and the factory owner asked Steiner to create a co-educational school for the workers' children.

X. Community Internet and ISP

The Constitutional right to free speech is a central pillar of any republic functioning democratically. Without it, we have tyranny.

The level of censorship of our free speech on the Internet has reached epic proportions under Covid that is reflective of dictatorships under Fascism.

For example, doctors successfully treating SARS-COV2 infected patients on the front lines with off-patent, effective, inexpensive and non-toxic therapies have been repeatedly censored on the Internet and had their licenses threatened or revoked. Why? Because Big Pharma and Big

Government cannot force a vaccine on us if the public knows there are more effective, non-toxic and inexpensive alternatives available.

In addition, world-renowned scientific researchers, virologists and epidemiologists are also being censored for questioning the lack of science, proper research and testing behind totalitarian Covid mandates. In addition, attorneys and activist groups are being heavily censored, particularly when making announcements about bills being presented to the state legislature to protect our God-given rights and Constitutional rights.

Corporate economic interests have fueled the corruption of greed in mind control schemes to tell us when to think, how to think and what to think. This is intentional. The wealthy elite wants total socio-economic control of the masses. They believe they are the masters of our Universe and that we exist as commodities to consume their products, and to be traded to serve their ideology. To further understand this, you can visit the World Economic Forum's web site and also read the writings of Klaus Schwab, the chief architect there. These people are not hiding their plans for how we live and breath and have openly and publicly indicated that they want to change what it means to be human – as in transhumanism.

The Internet Today

Contrary to popular opinion, the Internet is not a public trust. It is a private going business concern. The Internet is run by corporations of wealthy elite and, in order to achieve socio-economic dominance, they have to control free speech. This is how fascism works. **Therefore, in order to protect our free speech, communities either need to have a direct stake in running the Internet or stop interacting with it.**

Dependent upon how a state allocates broadband distribution, *it is possible for anyone to start an Internet service provider company.* This means it is possible for communities to own their own ISPs for the purpose of providing their own low-cost, freedom of speech Internet.

IT professionals living in communities can be engaged to build web browsers like duckduckgo that provide for uncensored search that is not monitored and manipulated in any way by corporate interests, thus ensuring that the Internet remains open and transparent.

Costs for community ISP startups are being researched right now.

And, A Not So Novel Idea

And here's an idea – close your cell phone facetime apps, get off Facebook and Instagram and Twitter and, instead, call those you want to speak with and arrange to gather and visit with each other people regularly. In a world more and more dominated by Big Tech, this is even more essential.

XI. The Monitoring and Prevention of Corporate Campaigns to Privatize Public Resources

The era of GMO foods has evidenced the fact that corporations have made repeated attempts to privatize our food supply. One only needs to read the transcripts of the court cases brought against Monsanto to understand this.

Under Covid, some government officials have floated the notion that organic whole foods will be infected with SARS-COV2, as further justification for genetically-engineered foods that are made with carcinogenic herbicides and pesticides like glyphosate. Such a declaration can lead to the same indemnification against all lawsuits that vaccine manufacturers now enjoy, thanks to our Congress and Supreme Court.

If these companies are granted the power to control our food supply under the PREP Act and state emergency acts under Covid, eventually they will own the food supply. This will be their pushback on huge losses on their GMO product due to increased public awareness and successful litigation against them.

As another of many examples, corporate pressure on government to privatize our water supply has reached a critical mass, with some elected officials in the U.S. now considering the introduction of bills to enact laws for same. They have tried this in other countries and you may be interested in viewing the documentary report of Bechtel's attempt to own the water supply in Bolivia.

After the Bolivian government, in return for a significant bribe, transferred ownership of the country's water supply to Bechtel, Bechtel successfully lobbied the Bolivian government to outlaw the collection of rainwater by farmers who could not afford to purchase water from Bechtel and were, instead, collecting rainwater for their crops. Another case is that of the genetically-modified mosquitoes that were recently unleashed in the state of Florida by Bio Tech companies who had obtained the backing of the state to do so.

Conglomerates are always looking to increase their market share by lobbying governments to back their proposals. The problem is there is often little incentive to enact the proper testing and safety measures to ensure no harm to the public. Instead, we have become the guinea pigs for testing their products.

For these reasons (and more), it will be a duty of Liberty Action Council to engage in community resource management, in order to monitor corporate special interest and lobbying campaigns designed to privatize our natural resources that belong to all, so that these attempts can be preempted.

XII. The Power of the Purse. End Mindless Consumerism.

As citizens and consumers, we have the power of the purse that should be exercised in situations where businesses are clearly censoring our free speech and violating our constitutional rights and civil liberties. There is no reason to continue to give such businesses our money, or use their Internet platforms that are designed to violate our privacy by selling us and data about our online behavior as commodities to big business, government and the intelligence community. We can stop frequenting their businesses and Internet platforms by organizing boycotts and taking our money elsewhere.

In addition, it is high time for us to stop engaging in mindless consumerism. In doing so, we are destroying our environment and, by 'looking the other way' in trading in truth for convenience, we are making the perpetrators of Fascism stronger and stronger.

Therefore, an aim of a Liberty Action Council is to encourage the development of a new, community-based culture in which small business networks, community gardens and farms and resource management teams can be created that are environmentally-friendly. Such networks can be established as alternative places of employment for our youth and can be

structured so that we do not continually send our money into the hands of those who want to manipulate our thinking and control our very bodies for their own profits.

XIII. National Virtual Call Center

We are establishing a virtual call center for use by liberty action councils in multiple campaigns to contact and engage the public by phone in educational initiatives designed to inform and encourage – with a call to action for further engagement. With the ever-increasing censorship of free speech that is taking place online, we need an alternative to communicate effectively with the public, and in a way that cannot be censored.

IMAGINE THIS

If we can establish one Liberty Action Council in every county of every state in the union, we will far outnumber the total number of corporate, special interest lobbyists in Congress and the state houses combined!

All of the above is now taking place in Ohio, in several counties. What about your county?
